V. Curriculum Corrections / Fast-Track Approvals

- A. Curriculum Correction: PHIL 270HF Honors Introduction to Asian Religions (effective date Fall 2025): GE proposed change FROM CSU GE Area C2 and IGETC Area 3B TO Cal-GETC Area 3B and UC transfer (UC TCA). Tabled at the October 2023 DCCC meeting.
[Cal-GETC takes effect Fall 2025; therefore, proposals with an effective catalog date of Fall 2025 will be submitted for Cal-GETC, rather than CSU GE and IGETC. Courses will still need to be approved for UC-TCA in June 2024. If courses are UC TCA-approved, then Scott will submit for Cal-GETC approval in November 2024. Cal-GETC approvals will be announced in May or June of 2025. PHIL 270HF will be on the DCCC agenda for the November meeting.](#)

VII. Announcements/Informational Items: *(John Ison, Chair)*

- A. Effective Dates: Endings and Beginnings

- B. John would like the committee and discipline faculty to stay within the timeline of the catalog and class schedule, since it takes many people and several months to implement all changes. There will be some Fall 2024 approvals in November, and very few in December, since curriculum requires state approval by March 2024 in order to be placed into the 2024-2025 catalog.
- C. CurricUNET: Cal-GETC areas added
- D. Heather added Cal-GETC areas to the GE screen in CurricUNET. GE proposals effective Fall 2025 or later should not include CSU GE or IGETC, since Cal-GETC is their replacement. Currently enrolled students may elect to complete the CSU GE and/or IGETC GE transfer pathways, but transferring students entering FC in Fall 2025 will be placed on Cal-GETC. Course revisions will add Cal-GETC areas, but will still keep CSU GE or IGETC on the GE screen until further notice.
- E. DCCC report
Cypress ESL faculty justified course proposal revisions with different class sizes than comparable courses at FC. The discussion raised larger questions about class size parity, adherence to the class size planning and resource document (CSPRD), and the possibility of updating the CSPRD in the future.
- F. Accreditation Update
Reps should remind faculty to provide feedback on the accreditation reports that will be sent to ASCCC.
- G. AB 1111 Update (Updated Summary Draft Report: see attached)
The Common Course Numbering draft report was given to the curriculum via email to review. State approval is expected by December.
- H. AB 928 Updates: Cal-GETC, ADT, and Title 5/AA GE
The Title 5 revisions to the AA GE pattern are expected to be state-approved soon. By law, Area F (Ethnic Studies) must be added to the AA GE pattern for a Fall 2024 effective catalog date.

VIII. Tech Review Clarification/Updates: (Guy Dadson, Technical Review Chair)

The six-year review calendar on the curriculum.fullcoll.edu website is not up to date. Guy will work on updating that calendar. Reps should contact him if they have tech review questions.

IX. Updated DE Addendum: (John Ison, Curriculum Chair) **TABLED**

John presented the revised DEA, but the committee had concerns. Suggested revisions include the following: removing “correspondence course” from the mode of delivery options section; clarifying the introduction to the mode of delivery options (page 3), and replacing the definition of “Hyflex” with a more accurate and comprehensive one. A revised DEA will be placed on the November 1 meeting agenda.
