VII. Announcements/Informational Items: *(John Ison, Chair)*

- A. GE deadline reminder
The UC TCA submission date is June 1, 2024 for course proposals with an effective catalog date of Fall 2025. Courses must be Board-approved by April 2024 in order to guarantee readiness for the June 1 UC TCA deadline.
- B. Fall 2025 planning
Fall 2025 courses should be prelaunched as soon as possible. If courses are not applying for a GE area, then they could be prelaunched as late as the first week of spring semester (or Feb 1 2024).
- C. Regional Curriculum Conference Report (Saturday, October 21)
The conference covered Cal-GETC, Title 5 AA GE revisions, Common Course Numbering, and Dual Enrollment. The timeline of Common Course Numbering may not be announced until the end of the year.
- D. Clarification: Repeatability of Credit Courses

The 2012-2013 Title 5 regulations concerning repeatability remain in place. There was a bill, recently vetoed by the Governor, attempting to revise the repeatability requirements.

IX. Articulation Report: *(Scott Lee, Articulation Officer)*

Cal-GETC replaces IGETC as of Fall 2025. COMM 100 F, 124 F and 135 F must be submitted to UC TCA and Cal-GETC. Scott reminded everyone to follow UC TCA and Cal-GETC's standards, and find comparable courses, before GE applications. Courses requiring UC TCA approval must be Board-approved by April 2024.

X. Update re: Title 5 AA GE revisions: *(John Ison, Curriculum Chair)*

At the regional conference they announced the Title 5 GE revisions were chaptered and we are waiting for the official publication announcement. ASCCC is encouraging community colleges to begin planning for local AA GE revisions. John predicts there might be a Fall 2024 implementation and Fullerton College should start preparing. John reviewed the guidelines, the changes, and the process.

XI. Mathematics Courses and Requisites: *(Abraham Romero Hernandez, Mathematics Dept. Rep, and Mathematics faculty)*

Mathematics department coordinator Nicole Rossi, and Mathematics faculty members Tim Cobler and Caleb Petrie, discussed proposals with the committee. They justified the pre-req addition to MATH 151 F and MATH 151HF. They explained how this is giving students an alternative prerequisite instead of adding to it. The VPI stated this would raise questions about the addition from DCCC, the Board of Trustees, and the state Chancellor's office. They will notice that math faculty are adding a pre-req instead of removing. This could come across as non-compliance of AB 1705. The curriculum committee heard what the math faculty had to say and took a vote on MATH 151 F and MATH 151HF. The motion passed unanimously.

The updated DEA was presented to the committee. A suggestion was made to change the word "both" to "simultaneously" on the Hyflex description.
