A. Scott sent out the list of the courses that will be submitted for CSU GE & IGETC.

**XI. Title 5 AA GE revisions:** *(John Ison, Curriculum Chair)*

A. Title 5 requires a minimum of 7 courses in 6 areas, as mandated by AB 928. Local colleges have the right to expand on that minimum number, based on student need. The committee started discussion on revisions. John reviewed a spreadsheet that shows several revision options if the curriculum committee and faculty would like to add to the minimum requirements. This will be an ongoing conversation.
